2. Introduction

PayU is obligated by Anti-Money Laundering law to verify customers in that context. This API allows to verify sellers from marketplaces.

We have following verification types:

- Full AML verification (data of seller + scans or pictures of documents + bank account for withdrawals)
- Only bank account for withdrawals
- Only AML verification (data of seller + scans or pictures of documents)
- Periodical re-verification full or partial (only indicated data or documents need to be provided)

Note: When documents and data requested by PayU are send (for all types of verification), to start verification process it must be followed by /complete request.

General flow of verification contains following steps:

- Initialization of verification can be done by both marketplace or PayU, depending on context.
- Marketplace provides seller data and documents.
- Marketplace informs PayU that all verification data have been collected (complete).
- PayU verifies provided data and determines verification status.
- Status of verification is sent to Marketplace. It may inform marketplace about the missing verification data or final verification status.
- If some data is missing, Marketplace must send them to PayU and again inform PayU all verification data have been collected (complete).
- If status is final verification is closed.

Verification can be initialized by both marketplace or PayU. Most common case for initialization by marketplace is registering of seller unknown to PayU.

Most common case for initialization by PayU is requirement of re-verification - when some of documents have expired or the verification is no longer valid .

3. Verification flow

3.1. Authorization

Every API request must be authorized. Authorization process is described under the link (only Oauth method is allowed):

During the verification process, please **do not** send multiple requests at the same time. Sending repeated requests without waiting for a response will result in a blocked verification and an error message from PayU.



POS which will be used for authorization should be indicated by Marketplace and should not change.

3.2. Initialization

3.2.1. Checking Registration

Note: This feature requires additional setting on the PayU side.

Endpoint /verification-advice allows verifying, on the basis of a Personal Identification Number or NIP number, whether a given individual/company has already been registered in the PayU system.

GET /api/aml-verification/v1/verification-advice

This endpoint is designed to verify the registration status of legal entities. To specify whether you want to check status of a company or an individual you have to add a **companyTaxId** or **personalIdentificationNumber** query parameter:

GET/verification-advice?companyTaxId=<TAX_ID>

• **companyTaxId** <string> - company tax id of entity.

or individuals:

GET/verification-advice?personalIdentificationNumber=<PERSONAL ID>

• **personalIdentificationNumber** <string> - personal identification number of individual.

Responses:

- Http 200 Advised verify action. Possible values:
 - FULL_ONBOARDING_REQUIRED full boarding process required,
 - **BANK_ACCOUNT_VERIFICATION_REQUIRED** only a verification transfer is required for verification purposes.
- Http 400 Invalid input query values.
- Http 404 Marketplace not found.

In case you received **BANK_ACCOUNT_VERIFICATION_REQUIRED** in response, you have to follow some additional steps:

- 1. Create verification with "type": "FULL" 3.2.2. Initializing Verification
- 2. Send basic seller data 3.3 Seller Data
- 3. Send account data -3.6.1. Verification transfer service
- 4. Send verification complete 3.7. Notification that collecting data and documents has been finished



After these steps you must make a transfer to trigger verification.

3.2.2. Initializing Verification

You have 90 days from the start of the verification process to submit all required documents. Otherwise, the process will be terminated with a NEGATIVE status.

In order to initialize verification, the following request must be send on /verification endpoint:

sellerId <string>

- unique id of seller (submerchant) given by marketplace side. This id must be constant for every verification concerning the same seller (submerchant).

type <string> - Verification type:

- PAYOUT_ACCOUNT_DATA initialized by marketplace side. The verification with this type should contain the data of payout account and seller (submerchant). If this verification initializes seller in PayU then seller data are required. If it is just account update, then only account data are required.
- FULL verification which requires providing by seller all data for AML4 and payouts, typically initialized by marketplace side.
- UPDATE verification typically initialized by merchant side, when seller (submerchant) updates its data (e.g. firm address). If merchant changes crucial data e.g. Tax id/ personal id, legal type, it is required to use PERSONAL_ID_TAX_CHANGE and CONVERSION respectively.
- REVERIFICATION verification typically initialized by PayU, when we require merchant to update his data (eg. no longer valid document).
- PERSONAL_ID_TAX_ID_CHANGE initialized by marketplace side. This allows to change PERSONAL_ID for private person or TAX_IDs for legal entity. Once the KYC verification process begins, the current account and payouts are blocked until verification is completed. If the process is interrupted (e.g. the company is unable to verify itself), PayU restores the old merchant account, thus unlocking the payouts on it.
- CONVERSION initialized by marketplace side. This verification type allows to change a private person into the legal entity. Once the KYC verification process begins, the current account and payouts are blocked until verification is completed. If the process is interrupted, PayU restores the old seller's account, thus unlocking the payouts on it.

Response for this request will be as follows:

• Http 200 - Success

verificationId <long> - unique id of the verification provided by PayU

status <string> - current status of the verification:

- **WAITING_FOR_DATA** status after initialization of the verification, when PayU is waiting for data or after exceeding transaction limits for the occasional transaction flow
- **WAITING_FOR_VERIFICATION** set when all the data were send to PayU (after complete)
- **REJECTED** set when there are some errors in the provided data. These status is send with error codes
- **POSITIVE** final status for approved verification
- **NEGATIVE** final rejection status

Obtained verificationId needs to be used for whole communication according this case.

3.3. Seller data

This is method that allows to send data of the seller (submerchant).

If you provide the values for address.country and personalIdentificationNumber/taxId, you can only update them by submitting a /verification request of type PERSONAL_ID_TAX_ID_CHANGE.

If you verified the associates through Authologic, please send additional externalVerificationData object containing details about verified documents and authologicConversationID.

3.5. Uploading documents

3.5.1. Uploading scan or picture of document

This method allows to upload these filetypes: PNG, JPEG, JPEG 2000, PDF, BMP, TIFF which maximum file size is 10 MB. There must be two requests for uploading document used: payu_widget or dataloading/files and dataloading/../documents. First request uploads the file into server whereas second connects the file to the appropriate submerchant, associate and verification. ID documents (ID Cards, Passports, Driving licenses) with multiple pages should be sent as follows:

- front side should be the first element in table 'files',
- the back side should be the second element in table 'files'.

3.6. Payouts details

To make a withdrawal, bank account number must be set for the submerchant. Bank account number must be provided by submerchant and then verified by crosschecking declarative data with the data from the bank. There are few verification methods — methods available for the particular implementation need to be agreed with PayU. Data must be sent to PayU using request:

3.10. Multi-accounting

Multi-accounting in PayU enables sellers to associate multiple bank accounts with a single **sellerId**. This feature is particularly beneficial for sellers who offer their goods on a single marketplace but across multiple markets that use different currencies. With multi-accounting, these sellers can have separate wallets within PayU and easily withdraw funds to the respective bank accounts associated with each market.

The Multi-Accounting service requires additional configuration from PayU, alongside specific requirements that the marketplace platform must meet. Prior to integration, please reach out to PayU to confirm compatibility of your platform with the Multi-Accounting service.



3.10.1. Adding Additional Bank Accounts for Specific sellerId

If a seller utilizes payoneer or worldfirst accounts, they are restricted to having only a single account. If they desire to transition to another account, they must commence a new verification procedure and substitute the existing account with the new one.

To add a new account for an existing **sellerId**, send a verification request with the **type**: **UPDATE** and the **overridePayouts** parameter with the value **false**.

3.11. Re-verification

PayU on base of risk assessment, to be compliant with law requirements, initiates periodical reverification of sellers. Reverification can be either full (type full), which means that seller needs to deliver all the data, which is the same as in boarding of a new merchant of the same type (legal form) or partial (type reverification) when PayU indicates which documents or data is required. It can be for associate – ID document, because of expiration or excerpt from commercial registry.
